ORDER:

In the reference 1st and 2nd read above, Smt. K. Vijaya Nirmala, TGT (Social) in waiting period has been involved in the acts of vandalism by willfully causing damage to the Government Property in TGSWREIS Head Office. The individual has defamed one progressive section of the Society and leveled unwarranted blame on reputed institutions. She has made baseless allegation of corruption related to transfers and the functioning of the Society. Moreover, she has made unwarranted media appearance, spreading false accusations. Further, she has exposed the health condition of an employee through public media which is unethical. Her defamatory statements have caused harm to the reputation of the TGSWREI Society. Additionally, she engaged in disruptive and unlawful behavior, creating a public nuisance. Through her actions, she has exhibited gross misbehavior and indiscipline, disrupting the healthy atmosphere of the TGSWREI Society.

AND WHEREAS, the undersigned after careful consideration of the available material and having due regard to the circumstances of the case is satisfied that, it is necessary to place Smt. K. Vijaya Nirmala, TGT (Social) in waiting period under Suspension with immediate effect in public interest pending detailed enquiry.

Now, therefore, in exercise of the powers conferred under Sub Rule (1) of Rule - 8 of T.S Civil Services (CCA) Rules 1991, the undersigned being the competent authority (appointing authority / any other competent authority) hereby place (s) the said Smt. K. Vijaya Nirmala, TGT (Social) in waiting period under suspension with immediate effect and she shall continue to be under suspension in public interest until the conclusion of the disciplinary proceedings.

It is further ordered that, during this order remain in force, Smt. K. Vijaya Nirmala, TGT (Social) in waiting period shall not leave the Head Quarters without obtaining the prior permission of the undersigned.

It is further ordered that, during the period of suspension Smt. K. Vijaya Nirmala, TGT (Social) in waiting period shall be paid subsistence allowance equivalent to the leave salary on half pay leave.

The Suspension proceedings are given in accordance with the powers bestowed on Secretary in accordance with the Standing Order No.3/97, dated 27-01- 1997 of the Society.

The Zonal Officer, Zone - VI is directed to make necessary entries in the service register of the individual.
